### Expectations

- The instructor / counselor will prepare and present a project as a part of the class.
- Scouts are still expected to be knowledgeable about the requirement component and understand the objectives to be accomplished.
- Scouts attending “clueless” will NOT be signed off just for attending. **BE PREPARED!**
